For and on behalf of the Governor of J&K State, sealed responses affixed with Rs. 6.00 (*Rupees six only*) revenue stamps are invited for Empanelment from competent, experienced and capable parties having the necessary technical competence and financial strength for developing *Small Hydro Electric power projects (upto 10 MW installed capacity)* in EPC Mode.

Separate sealed responses affixed with Rs. 6.00 (*Rupees six only*) revenue stamps are also invited from competent and capable local entities / startups having the necessary financial strength.

1. In case of Empanelment Document for EPC Contractor, w.e.f **20.07.2017 to 10.08.2017** by making payment of INR 20,000/- (Rupees Twenty Thousand only) / (USD \$350) towards the non-refundable fees by way of demand draft payable in favour of "Chief Executive Officer, JAKEDA".
2. In case of Empanelment Document for local entities / startups, w.e.f **20.07.2017 to 03.08.2017** by making payment of INR 10,000/- (Rupees Ten Thousand only) towards the non-refundable fees by way of demand draft payable in favour of "Chief Executive Officer, JAKEDA".
