- ii. set a definite time period within which all the approvals/clearances are provided to a project; and

- iii. facilitate removal of the impediments, if any, faced by the Developers/Department in the project execution cycle.

The Advisory committee may co-opt the Deputy Commissioner of the concerned district where the Small Hydel Project is proposed to be located.

The Science & Technology Department shall provide necessary inputs and project details to the Advisory Committee through the designated Implementing Agency for the purpose.
